

Research and Teaching Expectations for Chairs and Directors

Chairs and Directors are faculty members who are on a 12-month contract—they are not considered Administrative Professionals (APs). While there is some variation from college to college, chairs and directors serve at the pleasure of their deans. Whether or not you teach or do research as part of your contractual obligations is typically negotiable at the time of hire. University Policy 3.3.6 outlines the responsibilities, appointment, compensation, and evaluation and follows this section. It can be located at:

Deans recognize that Chairs and Directors may wish to keep up with scholarship in preparation for returning to faculty or preparing for promotion. Chairs/Directors are encouraged to discuss these opportunities and their career trajectory with their dean to ensure a clear understanding of the expectations of their role.

Chairs and Directors may be eligible for professional development funds, travel support, sabbatical leaves, and other support related to either teaching and/or research. The extent to which a Chair or Director is entitled to these types of opportunities varies by college.

Research Ethics and Compliance

The Office of Research Ethics and Compliance <http://research.illinoisstate.edu/ethics/> oversees university-wide compliance with federal, state, and university policies regarding the conduct of ethical research with humans and other vertebrate animals, regardless of funding source. The office also provides oversight and training in the responsible conduct of research across the University and assists the Office of Environmental Health and Safety in the oversight of research involving biohazards.

Student Attendance

The attendance regulation of the University is based on two principles. First, students are expected to attend class regularly; and second, students are primarily responsible to the instructor in matters pertaining to class attendance.

As a service to students, the Dean of Students Office <http://deanofstudents.illinoisstate.edu/contact/absence/> 438-2008, will provide notification to instructors when students have been/will be absent from class(es) for three (3) or more consecutive days and are unable to contact their instructors. Although it is the student's responsibility to contact faculty about any absences, the Dean of Students will serve as a contact resource for students.

Academic Advisement

- All undeclared students and students who have earned fewer than 24 semester hours are advised in the University College Academic Advisement, Fell Hall 340, 438-7604. <http://ucollege.illinoisstate.edu/advising/>
- Students with a declared major and over 24 credit hours completed are advised in their department/school. <http://ucollege.illinoisstate.edu/advising/departmental/>. One exception is students in the College of Business, students with majors in the College of Business and 24 or more hours are advised in the College of Business Advisement Center <http://www.cob.ilstu.edu/advising/>

- Student athletes are advised by academic advisors housed in University College. These advisors authorize schedule changes, as governed by NCAA Policies, for all student athletes including students assigned to academic departments for advisement.
- First-year Honors Program participants are advised through the Honors Program, Honors Program Building located on the corner of North and Fell Streets, 438-2559.

The e-mail request will be sent to faculty in the 5th week of the semester; a second request will be sent in the 11th week of the semester for only select populations of students. Faculty Attendance

Faculty members should regularly meet their assigned classes as scheduled. Faculty members who are absent from their duties because of illness or any other reason should report the fact immediately to their department chairperson or school director.

Office Hours - Faculty members are expected to post and observe a reasonable number of regular office hours, during which time they are available for student conferences. Faculty should announce their office location and hours to their classes. Additional appointment time should be made available when mutually convenient to faculty and students in instances where student schedules conflict with regular office hours.
