Academic Program Development: From idea to enrollment, I have led teams of faculty and staff to innovate new academic programs, including varied delivery modes, which have increased access to teacher licensure through multiple pathways for multiple learner populations:

- *Purple Pathway for Paraeducators* online, accelerated pathway to a bachelor's degree for paraeducators across the state of Iowa leading to dual licenses in elementary and special education.
- *Purple Pathway for Administrators* online, accelerated pathway to a masters degree in Principalship with Des Moines Public Schools, investing in talent development for a grow-your-own teacher to administrator pathway, including advanced licensure.
- Degree in Three a partnership with UNI, Hawkeye Community College and Waterloo Community Schools Career Center allowing students to be licensed and start working as a teacher just three years after their high school graduation with streamlined articulation among the 3 institutions.
- *Master of Arts in Teaching (MAT)*: Effective Fall 2025, UNI will start an MAT program for secondary career changers, equipping professionals from other fields with essential teaching skills and licensure to transition into secondary (grades 6-12) classrooms.
- *Transformative Education Master of Arts in Education*: Effective Fall 2025, this program aimed for current educators will empower individuals to critically examine their beliefs and values, fostering meaningful change in themselves and their communities by challenging existing social, economic, and political structures.
- Al for Educators graduate certificate: Effective Summer 2025, prepares educators to understand Al concepts, integrate Al tools into teaching, foster innovation, and engage in discussions about Al's ethical and social implications in education.

Building Research Infrastructure and Capacity: Through my leadership, I have prioritized strengthening a culture of collective scholarly engagement and research support within the College of Education. I established a new associate dean role focused on faculty scholarship and research, fostering a proactive environment for academic inquiry. Programming resources increased as evidenced by the creation of scholarly engagement events, such as dedicated writing sessions and lunch-and-learn workshops on quantitative research, further enhancing faculty development. Additionally, I successfully advocated for increased graduate assistantships and tuition scholarships, improving support for both students and faculty. I spearheaded the shift of over 10 graduate programs to annual and rolling enrollment cycles, resulting in heightened accessibility and program growth, including increased enrollment in our doctoral program. Proudly, I established and now sustain an AACTE Holmes Scholars Program at UNI, currently supporting four Holmes Scholars. These efforts have significantly strengthened our research infrastructure, positioning the College as a hub for scholarly production.

College Leadership and Presence: As a leader committed to shared governance, I work to strengthen communication and engagement with the College of Education (COE) faculty senate, staff, and students to advance key initiatives across the college. I have also initiated and maintained reporting for *U.S. News & World Report*, resulting in our placement within the top 20% of online graduate education programs for 2024. In collaboration with the university's Facilities Management division, I oversee space reallocation and construction projects to support academic endeavors, ensuring that our physical environment aligns with the college's evolving academic needs.

Commitment to Inclusive Excellence: I actively address issues of diversity, equity, inclusion, and belonging by revising policies, protocols, and practices, with a particular focus on allocating resources to support faculty, staff, and students. Additionally, I refine student outcomes assessment processes for College of Education (COE) program coordinators, aligning efforts with university-wide goals for continuous improvement and compliance with Higher Learning Commission (HLC) standards. Furthermore, I facilitate the curricular and program revision of the EdD program, while supporting doctoral faculty in advancing the Carnegie Project for the Education Doctorate (CPED) model to enhance educational leadership.

Resource Procurement, Management & Growth: As chief academic officer, I manage a \$11 million general fund budget, using a historical budget model, alongside over \$6 million in self-support funds and due largely to a revenue share model with online courses. This financial oversight covers five academic departments, four centers of excellence, and over 25 academic programs, supporting a team of 100 full- and part-time faculty and staff. Despite the challenges of COVID-19, I successfully increased annual fundraising by 49% from FY20 to FY21 and boosted annual scholarship awards by 21% in FY22. Additionally, I enhanced scholarly engagement by securing funding for two sponsored lecture series, supported by notable private donors.

University-wide Educator Preparation Leadership: In my role leading teams in educator preparation, we collaborate closely with academic and co-curricular leaders on campus and across institutions, including statewide PK-12 school districts. Together, we support senior university administration, government relations colleagues, and policymakers by providing crucial advocacy data and narratives on legislation impacting both K-12 and higher education. Our team is driving the College toward a culture of assessment and data-informed decision-making, which was instrumental in securing state board of education approval during our successful 7-year visit in 2024. Additionally, we collectively secure more than 1,500 K-12 classroom placements each semester to ensure our students gain essential practical experience. A major initiative under my leadership is the *Teacher Education Curricular Transformation*, which updated a curriculum (foundations, content, methods and clinical experiences) that has not been thoroughly revised in over 30 years. With over 2,200 students—25% of UNI's student body—pursuing teaching degrees, these changes will affect 41 majors and minors across all four academic colleges. This transformation, initiated in Spring 2022, is set for full implementation by Fall 2025. This holistic approach strengthens our partnerships and advocacy efforts, aligning our programs with the

evolving needs of schools and communities.

Academic Advising: I provided strategic oversight for the College of Education's Academic Advising office, with a primary focus on enhancing the overall student experience. My work involved improving recruitment and retention efforts, as well as addressing barriers students encountered with registration and related systems. I introduced a more efficient, streamlined process for pre-registration and advising appointments, ensuring clearer communication and collaboration between advisors and department heads across the College. These initiatives improved the accessibility and quality of academic support for students, contributing to their academic success, time to degree and overall satisfaction.

Recruitment & Retention: I led multiple initiatives aimed at strengthening both recruitment and retention efforts. I re-established the College of Education's social media presence on platforms such as Facebook, Twitter, and Instagram, expanding our digital reach and engagement with prospective and current students. Additionally, I convened 14 student organization leaders to foster collaboration and improve student engagement, further enriching the student experience. I also spearheaded a collaborative effort with peers across campus and Regent institutions to enhance undergraduate recruitment. One of the key outcomes was the creation of the 'Made to Teach' event in 2019, which has since grown into the largest recruitment day on campus, drawing over 350 future educators annually. This event, now in its fifth year, has significantly increased the visibility and appeal of our academic programs, further solidifying my ability to drive effective recruitment and retention strategies.

Student Access Through Financial Stewardship: During my tenure, I played a pivotal role in administering and overseeing institutional and foundation scholarship funds. As the lead scholarship administrator for the COE, I facilitated the awarding of over \$1 million in scholarship dollars directly to students, marking a 25% increase from the previous year. This substantial financial support significantly contributed to both student success and retention.

During my tenure as Interim Dean of the School of Education at the University of Indianapolis (UIndy) from January 2017 to June 2018, I led efforts that elevated the institution's national standing and strengthened key partnerships.

CAEP Accreditation: Under my leadership, the School of Education earned national recognition as a CAEP (Council for the Accreditation of Educator Preparation) accredited institution. I oversaw all aspects of the institutional report and the site visit, which culminated in this prestigious

accreditation. Additionally, I fostered a partnership with the UIndy Center for Education Leadership and Learning (CELL), hosting four convenings with local PK-12 superintendents during 2017-2018. These gatherings promoted collaboration and dialogue around pressing educational issues.

Faculty & Student Support: One of my proudest accomplishments was the development of a Minority Teacher Scholarship for incoming education majors, which sparked vital campus-wide conversations about the need to diversify the teaching profession by recruiting more diverse teacher education candidates. To further engage students, I established the "Dean's Dozen," a group of 12 students from various School of Education programs, who served as an advisory board to the Dean's office. This initiative provided valuable student perspectives on the direction of the school. Additionally, I enhanced faculty research by achieving a 150% increase in grant funding within the first six months of 2017, strengthening our research output and capacity.

Recruitment & Retention: As Assistant Dean from June 2014 to December 2016, I developed the Early/Direct Admit program for undergraduates in collaboration with the University Admissions office, a strategic initiative to attract top talent directly into our education programs. I also took the lead on outreach, marketing, and enrollment, meeting with prospective students and their families during campus visits, and represented the institution at the Indiana Association of Colleges of Teacher Education (IACTE), the state division of AACTE. My administrative duties also included preparing, reviewing, and submitting CAEP annual reports and Title II reports, ensuring ongoing compliance and continuous improvement of our programs. Through these initiatives, I worked to elevate the School of Education and advance its mission.
